- **Armed Forces Outreach** – informs membership of collections, coordinates community service care packages, and events primarily in New Haven County.
- **Bylaws** – reviews the Bylaws, the Certificate of Incorporation, and applicable state and federal laws to recommend amendments as needed.
- **Membership** – mails membership applications to all members, responds to inquiries from non-members regarding membership, maintains membership directory, and updates NFPA concerning membership information.
- **Newsletter** – produces NHCAP's quarterly newsletter containing articles regarding local and national issues as well as information of NHCAP events and programs\
- **Nominating** – solicits nominations for the elected officers of NHCAP.
- **Paralegal Certification** – informs membership about PACE and PCC, encourages and promotes these examinations.
- **Pro Bono** – coordinates programs whereby volunteer paralegals can assist attorneys and/or legal assistance agencies, acts as a clearinghouse for information relating to pro bono opportunities.
